QUALIFICATIONS AND ELIGIBILITY FOR STATE OFFICERS

- A nominee for any elective state office must have previously served as a county officer or a member of the SCFCL Board.
- Each candidate for office must have agreed in writing to his/her nomination and have the written endorsement of his/her county association.
- A candidate shall be nominated for only one position in a given year.
- An elected officer may not resign from a presently held position in order to run for a full term position. An elected officer may resign to be appointed to fill a vacancy that has occurred during a midterm resignation or death.
- A candidate for Secretary should understand the importance of preserving the official records of SCFCL, have the ability to write accurate minutes, and provide a safe repository for official records.
- A candidate for Treasurer shall be eligible for bonding, knowledgeable in bookkeeping, and familiar with long and short term investments.
- A candidate for any elected state office shall have access to electronic communication.

Duties of the President-elect (complete list of duties are in SCFCL Handbook and at: scfcl.com)

- Attend all SCFCL board meetings, district meetings and Annual Meeting and serve with vote.
- Study and become familiar with SCFCL Bylaws and Policies/Standing Rules.
- Have access to electronic communication.
- Serve as understudy to and receive training and guidance from the President, performing such duties as shall be assigned by the President.
- Serve as ex-officio member of all committees on which the President is serving.
- Perform all President's duties in the President's absence or inability to serve.
- Perform the duties of the President in case of resignation or death until the next meeting of The Board when the President-Elect is confirmed by The Board as President.
- Appoint a Parliamentarian, News and Views Editor, E-Membership List Coordinator, News and Views Mailer, Webmaster, and Project Chairs to serve concurrent to President's term beginning January 1.
- Work with the board to receive donations of approximately \$100 at the August board meeting to purchase a gift for the outgoing President.
- Keep a record of expenses and submit a signed voucher with receipts within sixty days; complete expense voucher in triplicate, attaching receipt(s) to the original; original with receipt(s) and one copy is sent to the President for approval for payment. President approves and sends the original with receipts to the Treasurer for payment. The third copy is kept in the officer's/chair's files.

Duties of the Treasurer (complete list of duties are in SCFCL Handbook and at: scfcl.com)

- Attend all SCFCL board meetings and Annual Meeting.
- Serve with vote.
- Study and become familiar with SCFCL Bylaws and Policies/Standing Rules.
- Have access to electronic communication.
- Receive and keep records of all funds of SCFCL and deposit as directed by The Board.
- Pay authorized expenses of SCFCL upon receipt of a signed voucher with receipts from the President.
- Present a statement of accounts at all meetings of The Board, and at such other times as the President may request.
- Receive membership lists, dues and any other contributions from each county and keep the E-Membership list accurate and up-to-date on Google Sheets.
- Make a full report at the Annual Meeting.

Duties of the District Directors (complete list of duties are in SCFCL Handbook and at: scfcl.com)

- Attend all SCFCL board meetings, district meetings and Annual Meeting.
- Serve with vote.
- Study and become familiar with SCFCL Bylaws and Policies/Standing Rules.
- Have access to electronic communication.
- Serve as a representative of District on The Board and coordinate activities in District.
- Serve as a member of the State Education Committee.
- Hold at least one meeting annually of each district. When possible hold a Spring and Fall Meeting to include agenda items with input from SCFCL Board, coordinated by SCFCL President.

2022-2023 State Project "BEE-Cause Pollinators Feed the World" Project in Common with NVON

"BEE-Cause Pollinators Feed the World" is an international project in Common with the National Volunteer Outreach Network. Its objective is to educate and inform members about the importance of pollinators and how we can be better stewards of the pollinators' role in the world's food supply chain. SCFCL can make a major impact with education and implementation of workshops, home gardens, flower beds and LOTS of other areas to help make members and others aware of the crisis with pollinators.

SCFCL members may not Bee pollinators but can Bee a voice on their Beehalf.

What is pollination?

- Pollination occurs when pollen grains are moved between two flowers of the same species, or within
 a single flower, by wind or animals that are pollinators. Successful pollination, which may require visits
 by multiple pollinators to a single flower, results in healthy fruit and fertile seeds, allowing plants to
 reproduce. Without pollinators, we simply wouldn't have many crops!
- About 75% of all flowering plants rely on animal pollinators and over 200,000 species of animals act as pollinators. Of those, about 1,000 are hummingbirds, bats, and small mammals. The rest are insects such as beetles, bees, ants, wasps, butterflies, and moths.

Why are pollinators important to us?

- Worldwide, approximately 1,000 plants grown for food, beverages, fibers, spices, and medicines need to be pollinated by animals in order to produce the goods on which we depend.
- Foods and beverages produced with the help of pollinators include blueberries, chocolate, coffee, melons, peaches, pumpkins, vanilla, and almonds. Plants that depend on a single pollinator species, and likewise, pollinators that depend on a single type of plant for food are interdependent. If one disappears, so will the other.

Lexington County

Lexington County FCL currently has five clubs and eleven Associate Members giving us about fifty seven members. Since the COVID pandemic necessitated the cancellation of our Fall County Meeting in both 2020 and 2021 we decided not to wait another whole year, but instead we held the Lexington County Meeting in March 2002. Erika Hwang, Lexington's 4-H & Youth Development Agent gave a very informative talk about the 4-H Program, which offers hands-on learning to everyone ages 5-19. She is implementing many new programs including a program for performing and visual arts. Erika is doing a great job of developing and promoting all the 4-H programs! Dale Morrow, Vice President for Programs and the SCFCL Project Chair, shared information about our State Project In Common With NVON, "BEE-CAUSE Pollinators Feed the World.

The Herb Bunch's 10th Annual Herb Festival held on March 26, was a notable success! There were over 100 varieties of plants and herbs for sale along with a Bake Sale. There was also a container gardening booth. There were several vendors present representing the Lexington Soil & Water Conservation District, and the Herb Bunch Education booth with our Lexington Master Gardener Molly. Proceeds from this Festival will contribute to scholarships for students in our County who plan to major in college in the areas of pariaulture, parihusing potentiaulture, putrition or guilager

Our Ways and Means Chairman, Judee Shelley, has coordinated another successful pecan sale. We sold a quantity of pecans sufficient to net a profit of \$440 which will be allocated to help support Lexington County Family and Community Leaders' goals.
